Thank you for contacting me about the decision by GM to only assume the Delphi hourly-retiree pension obligations, leaving the pension obligations of the Delphi salary-retirees vulnerable to being taken over by the Pension Benefit Guarantee Corporation (PBGC). I share your outrage about this decision and I appreciate you bringing this urgent situation to my attention.

Former salary and hourly workers of the Delphi plant in Oak Creek, Wisconsin have suffered a great deal as a result of the closing of this plant. The Delphi and GM bankruptcy process has added additional uncertainty to an already very difficult time for Delphi retirees. Even worse, if PBGC takes over the Delphi salary retiree pension obligations, these retirees could see their pension benefits cut significantly or eliminated entirely. Salary and hourly Delphi retirees at Oak Creek, Wisconsin worked side-by-side for years, mostly as GM employees. The decision by GM to create a double standard among these Delphi retirees is unfair and wrong.

Taxpayers have a 60 percent stake in GM. Delphi salary retirees, as well as all American taxpayers, deserve answers on why and how this decision was made. I have asked the House Financial Services Committee Chairman, Barney Frank, and Ranking Member, Spencer Bachus, to hold immediate committee hearings investigating this matter and what role the Federal government had in this decision. I have also asked U.S. Secretary of Treasury Timothy Geithner to provide and make public all documents related to the decision to separate the pension obligations of the salary Delphi retirees from the hourly Delphi retirees. I have enclosed for your review copies of the letters I have sent on this urgent matter. It is my hope that the Majority in Congress will make this a top priority and take action prior to the bankruptcy court's consideration of the Delphi reorganization plan on July 23, 2009.
